The second component will test your knowledge of traffic rules and laws you may encounter on the knowledge exam. The traffic rules and laws are found in Chapters 6, 7, and 8 of the Driver's Manual. On the actual knowledge examination, you must have 80% or higher correct on each component to pass the exam.

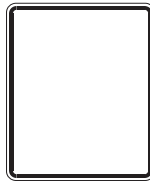

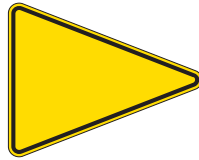

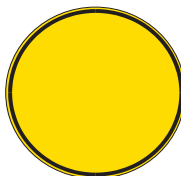
